



Terms and Conditions: “Win a Car 2026” Competition

1. Promoter

The promoter of this competition is AHEERS (hereinafter referred to as “the Promoter”).

2. Competition Period

The competition begins on Monday, 4 May 2026, and ends on Wednesday, 30 September 2026.

The main prize draw will take place on Wednesday, 28 October 2026. The exact date and venue will be communicated to finalists in advance.

3. How to Enter

- Spend a minimum of R500 in a single transaction at AHEERS.
- The purchase must include participating advertised products.
- Only cash and card purchases qualify.
- Entrants must ensure that their AHEERS Rewards membership is used or recorded at the time of purchase to qualify for entry.
- Each qualifying transaction constitutes one entry into the competition

4. Eligibility

- Entrants must be registered AHEERS Rewards members.
- Entrants must be 18 years of age or older.
- Entrants must be legal residents of South Africa.

- Entries must be made in a personal capacity; businesses or legal entities may not enter.
- The following persons are not eligible to enter:
 - Directors, shareholders, employees, agents, or consultants of the Promoter
 - Supplier representatives associated with the competition
 - Immediate family members (spouses, life partners, parents, siblings, or children) of the above
 - Business partners of the above

5. Draw Process

- Two finalists will be drawn each month during the competition period (one mid-month and one at month-end).
- Finalists will be selected by an independent person through a random draw using entry slips.
- A total of 10 finalists will be selected for the main draw.
- If a selected entrant cannot be contacted or is found to be ineligible, an alternative finalist will be drawn.

6. Final Draw Event

- All finalists are required to attend the main draw event.
- The date, time, and venue will be communicated to finalists in advance.
- If a finalist is unable to attend, a replacement finalist will be drawn.

7. Prizes

- The main prize is a vehicle.
- The prize is non-transferable and may not be exchanged for cash or any other goods or services.

8. Winner Obligations

- The prize vehicle will be branded with the Promoter's marketing materials.
- The winner must keep the branding on the vehicle, unaltered, for a minimum period of 12 months from the date of delivery.

- The Promoter may request photographs of the vehicle or require the vehicle to be presented for branding maintenance or replacement. The winner must comply with such requests.
- The winner may not sell, transfer, or trade in the vehicle during this 12-month period.
- The Promoter will remain the title holder of the vehicle for 12 months from the date of registration.
- The winner must obtain and maintain comprehensive insurance for the vehicle, including the branding, for a minimum period of 12 months.
- The Promoter may request proof of insurance at any time during this period.
- The winner is responsible for all fuel, maintenance, licensing, and running costs associated with the vehicle.

9. Winner Notification

- Winners and finalists will be notified once their entries have been verified.
- If a winner cannot be contacted or does not respond within a reasonable period, the Promoter reserves the right to draw a replacement winner.

10. Publicity and Marketing Consent

By entering this competition, participants consent to the Promoter using their names, images, and competition-related content for marketing, advertising, and promotional purposes without additional compensation.

11. General Conditions

- The Promoter's decisions regarding all aspects of the competition are final, and no correspondence will be entered into.
- The Promoter reserves the right to amend, suspend, or cancel the competition at any time without prior notice, for any reason deemed necessary.
- By entering, participants agree to receive promotional communications from the Promoter via email or SMS.
- All participants agree to be bound by these terms and conditions.

12. Protection of Personal Information

- Personal information collected during the competition will be used in accordance with applicable data protection laws, including the Protection of Personal Information Act.
- By entering, participants consent to the collection, storage, and use of their personal information for competition administration and marketing purposes.
